As a Disability Advocate-Yarn2Action, you will provide high-quality individual advocacy, information, referral, and direct support to clients across Rockhampton, Mackay, and the Wide Bay region. You'll support individuals to uphold their human rights, access services (including NDIS), and build community connections in a culturally safe and inclusive way.

- Identify service gaps and contribute to policy and procedure improvements
- Maintain accurate records and meet service targets
- Participate in team meetings, case discussions, and quality improvement initiatives
